WHEREAS the petitioner above named through his Advocate Sri Kotagiri Sreedhar, presented this petition under Article 226 of the Constitution of India, praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an order, writ or direction more particularly one in the nature of writ of mandamus declaring the action of Respondents No. 2 to 4 (Particularly Respondent No.4) as illegal, arbitrary, unconstitutional and violation of Article 14, 21 of Indian Constitution in not considering the Representations dated 10-02-2025 given by the Petitioner to the Respondents No. 2 to 4 on 11-02-2025 and consequently direct the Respondents No. 2 to 4 (Particularly Respondent No.4) to Remove the Clause No. 3 in Election Notification dated 08-02-2025 issued by 4<sup>th</sup> respondent Pertains to Telangana State Arya Vysya Maha Sabha, which states the Eligibility to Contest as President and allow them to contest in the elections for the Post of President, by considering the representations dated 10-02-2025 given by the Petitioner to the Respondents No. 2 to 4 (Particularly Respondent No.4) on 11-02-2025;

AND WHEREAS the High Court upon perusing the petition and affidavit filed therein, and upon hearing the arguments of Sri Kotagiri Sreedhar, Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

Petition under Section 151 of CPC, praying that in the circumstances stated in the affidavit filed in the writ petition, the High Court may be pleased to pass an order directing the Respondents No. 2 to 4 (Particularly Respondent No.4) to consider the Representations dated 10-02-2025 given by the Petitioner to the Respondents No. 2 to 4 on 11-02-2025 and consequently direct the Respondents No. 2 to 4 (Particularly Respondent No.4) to Remove the Clause No. 3 in Election Notification dated 08-02-2025 issued by 4<sup>th</sup> respondent Pertains to Telangana State Arya Vysya Maha Sabha, which states the Eligibility to Contest as President and allow them to contest in the elections for the Post of President, pending disposal of WP No. 4259 of 2025, on the file of the High Court.

**Learned counsel for the petitioner submits that the petitioner on 10.02.2025 made representation and requested respondent authority to remove the Clause No.3 from the Election Notification dated 08.02.2025 and further submitted that inspite of acknowledging the same on 11.02.2025, no orders are passed and pray this Court to direct the respondent authority to consider the petitioner's representation dated 10.02.2025 and pass orders in a time bound period.**
